- I. DEMCO (No.225), LEE (No.226), MK (No.227), NOBLE (No.228), SINGER (No.229) and TRUBB (No.230) are set initial margin rate at 100%, margin call rate at 40% and force sale rate at 30%.
 - II. BROOK, CTW, MFEC, NETBAY, OISHI, SUSCO, TCMC and TTA which eight stocks, are still maintained on the marginable list but they are not allowed more purchasing and depositing.
 - III. Non-Voting Depository Receipt (NVDR) of 222 stocks are allowed for foreigner.
 - IV. All of above can be used as collateral for borrowing securities on Securities Borrowing and Lending activities (SBL).
 - V. Above stocks are not allowed more purchasing and depositing once they are on the Turnover List.
